How to claim CPD for your Apprentice Supervision work

As a qualified supervisor, you are entitled to claim hours per apprentice for the correction of work in relation to their case studies, up to a maximum of 7.5 hours in any one calendar year.

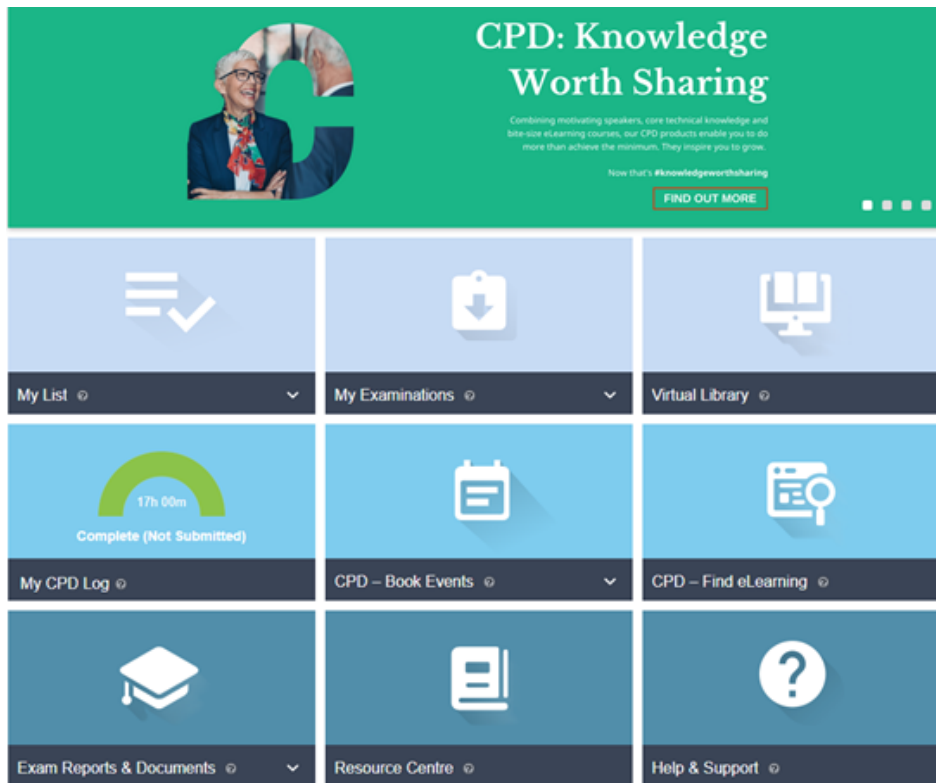
In respect of APA/ CIP/ QFA and Grandfathered persons*. This breaks down as follows:

- 1) Up to max of 2.5 hours per semester (there are 3 semesters, i.e. Sept – Jan, Feb – May, June – Aug) or 30 mins per case study.
- 2) A max of 15 such events can be added to your CPD portfolios if you are a recording member with us. (You can add the CPD hours to your own portfolio as they are set up as activities in Connect).

When adding the activities/events, you must attach the completed evidence form (i.e. the Case Study Marking form – the last page of case study document the apprentice submits), in pdf format.

To log your CPD, you should;

- 1) Log into your personal member area through www.iii.ie
- 2) Click on Connect
- 3) Click on My CPD log



4)Click on Add CPD

5)Type in Supervisor in Activity name
